

At Renvyle House we know dogs are part of a family and we gladly welcome our guests travelling with small to medium sized dogs. To make this possible we have a limited selection of ground floor rooms, with close access to our grounds, which are allocated to Guests travelling with their dogs; these must be booked in advance to secure room as they cannot be accommodated in other bedrooms.

For the comfort and safety of all guests, we kindly request that all pet owners act responsibly with their pets and agree to our pet codes to ensure an enjoyable stay for all. ~ *Thank you.*

- Renvyle House welcomes small to medium dogs (maximum 40lbs / 18kgs).
- Maximum of one dog per guest bedroom allowed.
- Please contact the hotel prior to arrival to secure a 'pet friendly' guestroom for your booking. We will not be able to accommodate dogs in other guestrooms. (*We have designated specific pet-friendly guestrooms that are deep cleaned after every pet departure to remove allergens*).
- A pet fee of €15.00 per night. *This fee will not apply to guide dogs or assistive dogs.*
- Dogs must be fully toilet-trained.
- Dogs must be washed and on flea medication prior to arrival.
- Owners must bring pet bedding and a crate if they plan to leave pet in room unattended.
- Dogs are not allowed upon the furniture within the hotel.
- Any additional cleaning charges or damage will incur a charge.
- Dogs left unattended in the guest room must be secured in a proper pet carrier.
- Please inform Reception by dialling '0' of times when you may be out to allow Housekeeping in to clean your room.
- Please do not use guest towels in room for your pet. We have a supply of complimentary towels for our canine guests which can be ordered from Reception.
- To comply with health code regulations, pets are not allowed in the pool area, restaurant, bar or other areas where food is consumed. *Only guide dogs for the visually impaired are allowed in the bars and restaurants.*
- Pets must be kept on a leash at **all** times in the interior public areas and the exterior grounds of the hotel property.
- Owners are responsible for cleaning up after their pet on hotel grounds and properly disposing of the waste in the outside bins provided.
- If hotel management receives more than two complaints, alternative arrangements must be made for your pet. We ask that you provide us with a mobile phone number so we may get in touch with you in case you are not in your room and your pet is creating a disturbance to other guests.
- Certain breeds of animals will not be allowed based upon their inherent demeanour e.g. Pit Bull, Rottweiler, and any other breeds deemed dangerous.
- Dog owners are responsible for all personal injuries and/or property damage related to their dog. All owners should carry personal liability insurance, the hotel cannot accept responsibility for any actions taken by your dog during its stay in our hotel. A Guest declaration must be signed upon check in.

We hope you have an enjoyable stay with us, there are plenty of lovely walk both on the grounds and locally for you and your pet to enjoy. Here, the only stress is on Relaxation.
